Chairman Abrams opened public hearing concerning the two requested plat approvals. Messrs. Campbell and Brook presented the application. After discussion and questions/answers, Mr. Boice moved for Planning Commission to recommend approval of both requested plats. Ms. Enright seconded. Vote was 7-0 in favor. Motion passed.

Trustee Chiarelli made a motion to approve Bill No. 2015-06-08-01. The motion was seconded by Trustee Ware. Bill No. 2015-06-08-01 was read two times and became Ordinance No. 2015-06-08-01, AN ORDINANCE OF THE VILLAGE OF LOCH LLOYD, MISSOURI, APPROVING THE FINAL PLAT OF THE RESERVE AND LOW COUNTRY AT LOCH LLOYD IN CASS COUNTY, MISSOURI.

Trustee Chiarelli made a motion to approve Bill No. 2015-06-08-02. The motion was seconded by Trustee Ware. Bill No. 2015-06-08-02 was read two times and became Ordinance No. 2015-06-08-02, AN ORDINANCE OF THE VILLAGE OF LOCH LLOYD, MISSOURI, APPROVING THE FINAL PLAT OF WEST RIDGE AT LOCH LLOYD IN CASS COUNTY, MISSOURI.

Discussion and approval of audit – passed.

Trustee Little moved for first reading of Bill No. 2015-06-08-03. The motion was seconded by Trustee Chiarelli. Vote was 4-0-1 in favor. Motion passed. The title was read once: AN ORDINANCE OF THE VILLAGE OF LOCH LLOYD, MISSOURI, ADOPTING CERTAIN TECHNICAL CODES AND PROVIDING FOR THEIR ADMINISTRATION.
