When Final PS&E (Plans, Specifications and Estimates) are due, all other necessary work is to be completed by time of submittal, including D-12, R/W clearance, utility clearance, environmental clearance, agreements, and all permits obtained.

<sup>♦♦</sup> FHWA approval/signatures are due before 12:00 pm (noon) on the day of project advertisement on Federally funded projects.

Minimum 15 days between Award and Notice to Proceed; <u>anything less requires BCS approval and DETAILED JSP</u>. 15 day NTP still requires appropriate JSP for expedited contract execution. Districts should coordinate in advance with CO Design when planning to utilize Early Notice to Proceed dates.

The July Letting is tentative. CO-Design and Bidding & Contract Services group will determine necessity and provide notification if proceeding with respective letting and due dates.
